1. I HAVE JUST COME FROM A LUNCHEON WITH MY OWN KITCHEN
CABINET OF JAIME MICHELSEN URIBE, PRESIDENT OF THE BANK
OF COLOMBIA AND ONE OF PRESIDENTIAL CANDIDATE TURBAY'S
PRINCIPAL SUPPORTERS, ALVARO GOMEZ HURTADO, DIRECTOR OF
EL SIGLO AND ONE OF CONSERVATIVE PRESIDENTIAL
CANDIDATE BELISARIO BETANCOUR'S PRINCIPAL SUPPORTERS,
AS WELL AS MINISTER OF GOVERNMENT ALFREDO ARAUJO GRAU.
IT WAS THEIR VIEW THAT WE HAVE EMERGED FROM THIS MINI-
CRISIS WITH, IF ANYTHING, A NET GAIN. THEY DO NOT
BELIEVE THAT THE MINISTER OF DEFENSE'S LETTER WOULD
HAVE ANY APPRECIABLE IMPACT ON OUR POLITICAL STANDING.
IT WAS ALSO THEIR VIEW, HOWEVER, THAT I WOULD BE VERY
NAIVE IF I DID NOT CONSIDER THAT THE NARCOTICS ISSUE
WITH RELATION TO COLOMBIA AND SPECIFICALLY WITH
CONFIDENTIAL

RELATION TO DR. TURBAY WOULD NOT BE A CONTINUING ISSUE
IN THE PRESIDENTIAL CAMPAIGN. THEY SEE THE TURBAY-
NARCOTICS ISSUE AS HAVING SURFACED AFTER A LONG
PERIOD OF SUBTERRANEAN GESTATION. THEY WERE DIVIDED
IN THEIR OPINIONS AS TO WHETHER SUCH A PUBLIC AIRING
NOW IS A DISADVANTAGE OR ADVANTAGE FOR TURBAY. THE
TURBAYISTAS THINK IT IS GREAT.

2. I SPOKE TO THE MINISTER OF DEFENSE AND BERATED HIM MILDLY FOR VIOLATING THE TERMS OF OUR AGREEMENT. HE WAS MOST APOLOGETIC AND ASSURED ME THAT THIS WOULD AFFECT NEITHER HIS PARTICIPATION IN THE NARCOTICS PROGRAM NOR OUR PERSONAL RELATIONS. INTERESTINGLY, AN EXCELLENT SOURCE HAS INFORMED ME THAT THE MINISTER WAS DIRECTED TO DRAFT THE LETTER, ALONG THE LINES AS RECEIVED, BY PRESIDENT LOPEZ HIMSELF. I HAVE MY DOUBTS ABOUT THIS INFORMATION SINCE PRESIDENT LOPEZ INFORMED ME THAT HE WAS ANXIOUS FOR THE FUROR TO DIE DOWN. HOWEVER, MY SOURCE IS A CREDIBLE ONE.
